Warm Reminder / 溫馨提示

Dear Valuable Customers / 致各尊貴客戶:

We would like to remind you that all goods consigned for carriage by air by your company to FAST-LINK EXPRESS LTD are restricted to general cargo only. General cargo must not contain any explosive or incendiary device, and are protected to your best endeavor against unauthorized interference during preparation, storage and transportation. Moreover, the cargo should be prepared by reliable staff employed by your company. Under any circumstances that undeclared dangerous goods are spotted, your Company is to bear all the responsibilities and consequences.

Besides, it is always imperative that shipments containing electronic goods bear documentation like patent licenses of authorization letters issued by manufacturers concerned. Shippers and consignees should be clear about documentation requirements posed by different countries' customs. Failure to present the requested document may eventually cause inconvenience and consequential loss. Furthermore, it is an offence to import or export goods with forged trade marks or false trade description. Those imitative electronic goods are equally risk products which would possibly be held of eventually confiscated. Likewise, Air Sea will be liable for any consequences and will not waive any freightage, fuel and security surcharge and other relevant charges due.
